## Directions to Rush'N'Around Agility Center:

From north or southbound I-294: exit at I-80 west to I-57 south. Stay on I-57 south for 9.5 miles to the Manhattan-Monee Rd. (Rt. 6) exit and go West Stay on Manhattan-Monee Rd. westbound for 6.5 miles and turn south(left) at Rt. 45 (stop sign with flashing light). Continue south (2.5 miles) to Trial Site on the west side of Rt. 45.

The easiest route for those taking the I-355 extension is I-355 south to I-80 eastbound. Exit at Route 45 south (about 9 miles) to Trial Site on the west side of Rt. 45.



**Check-In** will be at 12:00pm Friday and 7:30am Saturday and Sunday. **Judging** will begin at 1:00 pm Friday and 8:30 am Saturday and Sunday. All dogs jumping 8" 12" or 16" are required to be measured unless you send a copy with your entry or present a permanent jump height card at the trial. Dogs jumping 16" in the Vet or JH Divisions do not need to be measured. Photocopies of cards are ok.

**Entry Fees:** \$12 per run. Early trial packages: All 3 days -- \$170.00; Sat. & Sun. - \$132.00. **All entries \$15.00 per run after January 21<sup>st</sup>.**

**Entries close** Saturday, January 21, 2012, 5:00 pm or when limits are reached after which no cancellations will be made to entries.

**Trial Site:** This trial will be held indoors on sand and rubber mulch mix. Building is heated with washrooms. Food will not be available on site. There are several fast food restaurants within 15 minutes of the trial site.

**Rings and Equipment:** We will use one 70' x 115' ring. Obstacles that may be used at the trial include: dog walk, A-frame, open tunnel, weave poles, hoops, winged and non-winged bar jumps.

**Awards:** All qualifiers and 1<sup>st</sup> through 4<sup>th</sup> place in all 5 jump heights will receive a ribbon. Chances Class is pass/fail and no placements will be awarded.

**Refunds:** No entry fee will be refunded if the trial cannot open or be completed by reasons of riot, civil disturbances, fire, Acts of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee. There will be no refunds in the event a dog and/or handler is dismissed from competition regardless of the reason for such dismissal. Refunds (less \$5.00 per day) will be given for bitches that come into season after the closing of the trial. The trial secretary must receive a letter of verification from a veterinarian before judging begins.

**HOTEL INFORMATION:** Exhibitors must contact motels directly and identify themselves as having dogs. Some require deposits; others take only small dogs. Please use extreme caution in the treatment of motel space.

## Important message from NADAC office:

Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the [NADACagility@yahoo.com](mailto:NADACagility@yahoo.com) list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the [www.NADACagility@yahoo.com](http://www.NADACagility@yahoo.com) list and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

**Levels.** Points earned at a higher level of a class, prior to the completion of the lower level title, will not be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

## SKILLED CATEGORY:

When entering the Skilled Category, all dogs **must jump 4" lower** than their Proficient, Standard Division jump height requires

## NON-JUMPING CLASSES – VETERAN HANDLER:

Disabled handlers or handlers aged 60 yrs. or older may opt to enter the non-jumping classes as a Veteran Handler and receive 10% more standard course time. This division is for handlers only. The 10% additional SCT is for qualifying purposes only for those who may need the additional time to negotiation the course due to physical limitations. Veteran Handlers in the non-jumping classes will be scored and placed with their standard division jump height. When entering as a Veteran/Disabled Handler, you must enter all classes and all dogs in this division for the weekend.
